V-meter, type: 8404/6, is used for measurement and display of voltage values in hazardous area. It is intended for installation in appropriate enclosure with degree of ingress protection of at least IP54 according to IEC 60079-0. Moving-iron measuring elements are used as measuring system.

SCHEDULE OF LIMITATIONS:

Schedule of limitation:

- · V-meters must be completely installed in an enclosure with degree of ingress protection of at least IP54 according to IEC 60079-0.
- Creepage distances and clearances between the connection terminals and the enclosure parts must be kept according to IEC 60079-7, Table 2.
- V-meters are suitable for following temperature classes within corresponding ambient temperature ranges at location of installation:
 - temperature class T4 ... -55°C or -40°C \leq T_{amb} \leq +70°C
 - temperature class T5 ... -55°C or -40°C ≤ T_{amb} ≤ +55°C
 - temperature class T6 ... -55°C or -40°C ≤ T_{amb} ≤ +40°C

Note: If additional suffix "(-40°C)" is added to the type reference on the marking label, then the V-meters are suitable for minimum ambient temperature of -40°C, otherwise they are suitable for minimum ambient temperature of -55°C. For details see Operating instructions.
