

IMPORTANT SAFETY NOTE

Emergency switch off / Emergency stop switches 8003 series for panel mounting from the delivery period 01.01.2014 to 31.12.2016

Dear Sir or Madam,



Switches delivered in the period from 01.01.2014 - 31.12.2016 may be affected.

It was determined that some of these switches are missing latching hooks in the inner back enclosure piece due to a sporadic tool defect.

This leads to misalignment of the two housing parts (front and back piece) under the operating conditions of the switches. In very rare cases, this results in a loss of function, which carries the possible consequence that machines or systems cannot be shut off.



As the Emergency switch off / Emergency stop function is critical to system and machine safety, we strongly recommend retrofitting all housings from the abovementioned delivery period with a safety clamp (locking plate) and replacing the 8602/2 actuators.

The required assembly instructions are enclosed with the products. You can download the installation instructions of the respective products in advance at www.r-stahl.com/emergency-info.

The actuators 8602/2 which will be delivered as replacement parts, equipped with a silicone seal that enables an extended operating range down to -50 °C.

If the 8003 series switches are not in use at your own facility, but have been passed on, please notify the recipient by forwarding this safety note.

Switches with the order numbers in accordance with Annex 1 delivered to you as an individual product (component without name plate) or installed in systems are affected.

The system in which the switch is installed is identified according to Annex 1 (name plate).

The modification can be performed by qualified personnel according to the corresponding assembly instructions.



We would like you to confirm the completion of the work by marking the designated field in "U" column in Annex 1 and adding a company stamp or initials to the respective sheet. Please send us the sheets together with the enclosed signed declaration (Annex 2).
